RV MUST BE PAID ON ONLINE at www.wspchshow.com. No holding spots for trailers. Per Fairground Rules; No rollerblades, skateboards, bicycles, scooters or other vehicles allowed on the fairgrounds.

Dogs are not allowed within the Equestrian Park by order of the Fairgrounds. This is a Snohomish County Law and the Fairgrounds will enforce. They must be secured to an RV or trailer outside parking areas only or in the barn in a tack stall. Dogs may not be loose in barns.

Handicapped permits may be issued at the Fairgrounds office for assistance vehicles.

From the North: Head South on I-5, Merge onto US-2 East via EXIT 194 toward SNOHOMISH/WENATCHEE, Turn LEFT onto 179th Ave Se, End at 14405 170th Ave Se, Monroe, WA 98272
